Quick Scan Survey Results

April 29, 2024

METHODOLOGY

On Monday, April 29, 2024, NASFAA distributed an online poll to our membership via *Today's News*. This poll was open until 12:00 a.m. PT on Wednesday, May 1, 2024. There were 255 responses submitted. NASFAA does not display survey results if the sample size is less than five.

Note: This poll asked respondents to provide the percentage of their admitted first-year undergraduate students who had not yet filed a FAFSA for 2024-25, and the percentage of this population who had not yet filed their FAFSA for 2023-24 at around this time last year. Due to the low response rate of this question NASFAA is unable to publish the analysis of this question.
